## What data do we collect and for what purpose?

The following data are collected from SCOOP members and relations for specific purposes:

Work postal address	Sending hard copies (Annual Report, dissertations etc.)

Gender	For personal communication and statistics
Private email address, private address, private phone number	Communication with alumni
Work phone number	For personal communication on specific issues
Project title and description	For internal communication External: information on public website
Previous jobs, following jobs (after leaving SCOOP), additional functions, start date and end date PhD contract, defense date, date of birth, date of master diploma	For internal research on career development (not published on the website)

## More details:

Database & location	Personal data from SCOOP members are collected and saved in Excel databases in a protected data storage environment at the Unversity of Groningen. Partly data can be found on the SCOOP website.
Security	SCOOP takes the protection of your data seriously and takes appropriate measures to prevent abuse, loss, unauthorized access, unwanted disclosure and unauthorized changes. If you have the impression that your data are not properly secured or there are indications of abuse, please contact the SCOOP office.
Period	Personal data will be saved for an unlimited period in order to enable research on career development.
Sharing data	Personal data will not be shared with any other parties except with consent.
Cookies	Cookies are used by Google Analytics and Twitter
Automated decision making	SCOOP does not make decisions based on automated processing about matters that can have (significant) consequences for people.
Your rights	You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent for data processing or to object to the processing of your personal data by SCOOP and you have the right to data transferability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to our secretary. To ensure that the request for inspection has been made by you, we will have to determine your identity. We will respond to your request as quickly as possible, but within four weeks. SCOOP would also like to point out that you have the option of submitting a complaint to the Dutch Data Protection Authority.
